Greetings on behalf of Sepaktakraw Federation of India !!!

With regards to the allotment of the Asian Sepaktakraw Championship to India with host City Goa in the month of March I would like to inform you that due to the ongoing conflict between Court and Ministry of Sports (Government of India), we are yet to get approval of the Championship from the Government. The hearing of case is ongoing and based on the latest boundation issued by the Court, the Ministry of Sports should not approve any financial assistance to National Sports Federations (NSFs) with regards to Participation in tournaments and conducting Championship due to which the Government is not in a position to give clearance for the Championship and is delaying the process.
